WB Youth Coalition seeking \$100,000 grant

Secretary PAUL LIPSON, Our Club's representative on the West Bloomfield Youth Coalition, announced that the Coalition is seeking a \$100,000 federal grant in support of an education program aimed at drug and alcohol abuse among youths.

Recently, member DAVE KARAGOSIAN supplied a big boost to Our Club's mentoring program – in association with the Youth Coalition – with a generous contribution of \$500. The program involves eighth grade students from Abbott Middle School mentoring second-, third- and fourth-graders from Roosevelt School.

501(c)(3) Update: In progress

Optimist International reports on its web site that it is making progress with respect to Optimist International's application for group exemption under Section 501(c)(3). The IRS agent reviewing OI's application is reviewing documents submitted by in excess of 1,000 Clubs – *including Our Club's*. The goal is to try to bring closure to the process in the first quarter of 2007; however, not all Clubs have submitted information to OI's central office. 'Be alert' for ID thieves **Identity Theft** occurs when someone (the "perpetrator") wrongfully acquires and uses a consumer's personal identification, credit or other account information. The perpetrator may use this information to obtain money, credit, goods, services and other things of value in the victim's name. The perpetrator may also use this information to gain access to the victim's bank accounts.

HOW TO PROTECT AGAINST IDENTITY THEFT

• Do not routinely carry your Social security card, birth certificate, passport or more than two credit cards.

• Always carry away credit card, debit card and ATM receipts with you.

• Don't leave bill payment envelopes at your mailbox for the postal carrier to pick up.

• Destroy unused pre-approved credit card solicitations and convenience checks.

• Eliminate pre-approvals by calling 888-567-8688 (Opt Out Line).

• Immediately review your credit card statements, utility bills, telephone bills for unauthorized use. Contact the provider of necessary if you suspect unauthorized use.

• Order your credit card reports annually and review for accuracy and fraud. Free Credit Report Program Underway: Federal Trade Commission is rolling out service in phases; Michigan residents have been eligible to request free credit reports from three major credit bureaus since March 1, 2005. Program is designed to help consumers get better understanding of their credit and to promote accurate consumer information.

• Never give out your credit card, bank account or Social Security number over the telephone unless you initiated the call and you are familiar with the caller.

• Guard against overuse of your Social Security number: Don't print your social security number on your checks. If a business requests to use your Social Security number, ask to use an alternate number. If you don't receive your credit card statement on time, call the creditor and the post office to see if a recent change of address has been filed. If you shop on the Internet, use a secure browser for your purchase transactions.

• Make a list of your credit cards and bank statements in case your cards are lost or stolen.

• Cancel your unused credit cards.

• Don't use all or part of your Social Security number in creating passwords or PINs. Memorize all passwords or PINs.

• Check your Social Security earnings and benefits statement annually.

Consider having your name removed from marketing lists: (a) To remove name from direct mail lists, write to DMA Mail Preference Service, P.O. Box 9008, Farmingdale, NY 11735-9008. (b) To reduce phone solicitations, write to DMA Telephone Preference Service, P.O. Box 9014, Farmingdale, NY 11735-9014. (c) To join National Do-Not-Call List, call toll-free number 888-382-1222 or go online at www.donotcall.gov

• Consider not listing your number in the telephone book or list only limited information.

- Shield the keypad when using the ATM machine.
- Install a lock on your mailbox or use a post office box.

• Pick up new check orders at your financial institution instead of mailed to your home.

• When you fill out a loan application, make sure the financial institution shreds or locks up your confidential information.
